

Privacy Policy

At **BIG BLUE MARKETING LLC**, accessible from bigbluemarketingconsultants.com, one of our primary concerns is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by bigbluemarketingconsultants.com and how we use it.

This Privacy Policy discloses the privacy practices for bigbluemarketingconsultants.com and applies solely to information collected by this website.

It will notify you of the following:

- What personally identifiable information is collected from you through the website, how it is used and with whom it may be shared.
- The security procedures in place to protect the misuse of your information.
- How you can correct any inaccuracies in that information.

This policy is not applicable to any information collected offline or via channels other than this website.

We are the sole owners of the information collected through this site. We only have access to/collect information that you voluntarily give us via email, form or other direct contact from you. We will not sell or rent this information to anyone.

We will use your information to respond to you regarding the reason you contacted us. We will not share your information with any third party outside of our organization, other than as necessary to fulfil your request.

Unless you ask us not to, we may contact you via email in the future to tell you about specials, new products or services, or changes to this privacy policy.

1. Your Access to and Control Over Information

You may opt out of any future contacts from us at any time. You can do the following by contacting us via the email address or phone number given on our website:

- See what data we have about you, if any.
- Change/correct any data we have about you.
- Delete any data we have about you.
- Express any concern you have about our use of your data.

2. Security

We take precautions to protect your information. When you submit sensitive information via the website, your information is protected both online and offline.

Wherever we collect sensitive information (such as credit card data), that information is encrypted and transmitted to us in a secure way. You can verify this by looking for a lock icon in the address bar or looking for “https” at the beginning of the page address.

While we use encryption to protect sensitive information transmitted online, we also protect your information offline. Only employees who need information to perform a specific job (for example, billing or customer service) are granted access to personally identifiable information. The computers/servers in which we store personally identifiable information are kept in a secure environment.

3. Consent

By using our website, you hereby consent to our Privacy Policy and agree to its terms.

a. Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

If you register for an Account, we may ask for your contact information, including items such as name, company name, address, email address, and telephone number.

b. How we use your information

We use the information we collect in various ways, including to:

- iii. Understand and analyze how you use our website
- iv. Develop new products, services, features, and functionality
- v. Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes
- vi. Send you emails
- vii. Find and prevent fraud
- viii. Log Files

bigbluemarketingconsultants.com follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and are part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. These are not linked to any information that is personally identifiable. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

4. Cookies and Web Beacons

Like any other website, bigbluemarketingconsultants.com uses 'cookies'.
